The property is the site of the former Forestburgh Country Club Golf course and consists of a 6,000+/- yard 18-hole golf course including several irrigation ponds and clubhouse. The proposed project, Another Sky Campground, includes a 100 site, tent only, campground and supporting facilities to be located on the former Forestburgh Country Club site at 80 Tannery Road. Based on the concept developed by Another Sky, the facility will be a full service campground and consist of the following facilities/programs: Camp Store and Cafe (Registration/convenience shop, Equipment rental, Laundry facility, Food storage, Clubhouse/café) Family, Adult and camping sections (Individual campsites, Shower and restrooms) Community Areas (Playground, Swimming pond, Picnic pavilion, central fire pit/prep station, outdoor event space, and maintenance and storage area/building.
