Monticello School District Budget Vote

Residents will go to the polls on **May 21st** to vote on this year's school budget, elect school board officials and to vote on two additional propositions on the ballot—an \$85.5 million “Classroom2020 Phase II” capital improvement project and the creation of a \$10 million capital reserve fund. The capital improvement project has an anticipated annual maximum tax impact of \$2 per \$1k in assessed home value. The creation of a capital reserve fund, we're told, would not impact taxes. Dear Forestburgh Day Camp Parent or Guardian,

I hope that your year has been going well and that your child/children are thriving in school. As spring approaches, I'm sure they will be itching to get out and enjoy the sunshine. I know that the promise of sunshine and warm weather has me very excited for the upcoming 2019 Summer Season.

After conducting the satisfaction survey at the close of last summer, it was brought to my attention that many of you parents struggle to get your child/children to camp at 9 AM and pick them up by 3PM. There has been a change to the camp program this season. I am excited to announce that this summer; the Forestburgh Day Camp will be offering an Extended Hours Program. Parents will be allowed to drop their child off at camp at 8AM and pick them up at 4 PM. The cost of the program is \$50 per week for both AM and PM session, or \$25 for one session. It is an additional \$10 for each sibling. For example, if you have 2 children attending the program for AM and PM session the cost would be \$60 per week. This program, while approved by the town supervisor, **is not part of the camp program**, but more like a latchkey program. Therefore, the fee for the program will be used to pay the staff members that will be watching your children for the extended time.
