Town Board

Due to the Covid-19 pandemic the monthly Forestburgh Town Board meetings will be held the 1st Thursday of every month at 6pm at the Forestburgh Fire Department, located at 2359 State Route 42, Forestburgh until further notice. The next Town Board meeting is scheduled for **Thursday, December 3, 2020 at 6:00pm** at the Forestburgh Fire Department, located at 2359 Route 42. At the November meeting the Town Board adopted the 2021 budget. Even though the Town lost \$45,000 in State Aid the board was able to achieve a 2.4% reduction in taxes to be collected. Planning Board

Thanks to the generosity of the Forestburgh Fire Department, October's Planning Board meeting was held in person at the firehouse. We were able to observe all Covid-related distancing and face-masking requirements. Two matters were addressed: The first was an application for a Natural Subdivision of an 86+ acre single tax parcel owned by the Antlers Hunting and Fishing Club. This application to divide their single tax parcel into two separate parcels, along the divide created by the Oakland Valley Road was granted. The second matter addressed by the Planning Board was the 21 lot subdivision of the 548 acre parcel at the corner of Rt 42 and Hartwood Rd. This major Subdivision, known as Forestburgh Pond, received preliminary approval, subject to certain conditions. This culminated a process that began in January of this year and involved numerous meetings, investigations, extensive public and 'expert' input and modifications of the original plans, as submitted. As no applications have been submitted to the Planning Board for our November meeting, and there are no pending matters, **There will be no November Planning Board meeting.**

Zoning Re-Write Committee

The next scheduled November meeting is set for November 24th from 7-9pm at Town Hall. All CDC guidelines will be in effect. All in attendance must wear face coverings and maintain social distancing rules.

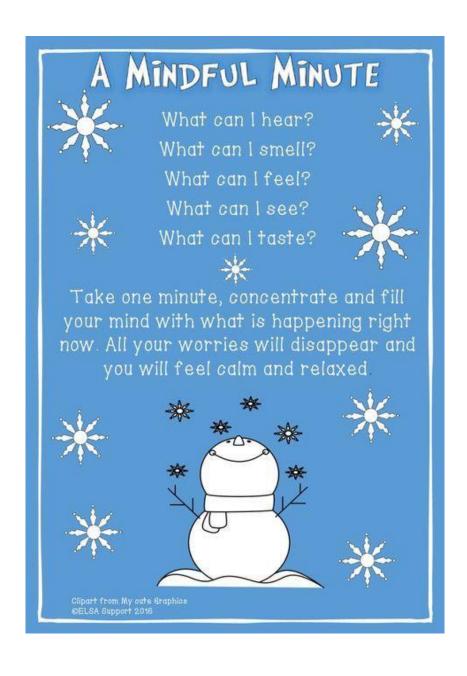

Mulled Apple Cider:

8 cups of your favorite apple cider 4 or 5 cinnamon sticks 1 medium sized orange whole cloves extra cinnamon sticks for serving

Pour apple cider into a 3 ½ quart crock pot. Add 4 or 5 cinnamon sticks. Punch holes in the orange with a toothpick and stick in whole cloves. You can add as many or few as you like. I usually just make several rings around the orange with the cloves. Place the orange into the crock pot. Heat on low for about 4 or 5 hours. Remove orange and cinnamon sticks before serving. Place a fresh cinnamon stick in each mug before filling with mulled cider. Enjoy! Makes 8 cups.

Note: This will keep for several days in the refrigerator and can be reheated in the microwave when you want to enjoy a cup. Your house will smell wonderful when this recipe is simmering in the crock pot.
