Gifford Shriver – I have a question about the franchise fee – are those fees that are collected from the customers and passed directly back to the town or are they paid and funded by Spectrum? Mr. Carmada explained they are paid by the paying subscribers. It is paid by participating residents of the town who use Spectrum.

No one else spoke in favor or against the franchise agreement.

MINUTES – Clerk Nagoda submitted minutes of the October 14, 2021, Budget workshop for review. MOTION by Councilwoman Landis, seconded by Councilman Budofsky to accept the minutes as presented. Vote: 4 ayes – 0 nays. Councilman Galligan abstained.

GENERAL FUND VOUCHERS - #35 - 61 in the sum of \$18,940.74 as set forth in abstract #3 were audited for payment. MOTION by Councilwoman Landis, seconded by Councilman Budofsky to accept the general fund vouchers. Vote: 5 ayes - 0 nays. Motion carried.

HIGHWAY FUND VOUCHERS - #20 - 31 in the sum of \$21,368.27 as set forth in abstract #3 were reviewed for payment. MOTION by Councilwoman Landis, seconded by Councilwoman Ellsweig to accept the highway fund vouchers. Vote: 5 ayes -0 nays. Motion carried.

ESCROW FUND VOUCHERS - #1-2 in the sum of \$1,390 AS SET FORTH IN ABSTRACT # 1 were reviewed for payment. MOTION by Councilman Budofsky, seconded by Councilwoman Landis to accept the Escrow Fund Vouchers. Vote: 5 ayes – 0 nays. Motion carried.

CORRESPONJONECE -

First, we have that the New York State Burn Ban is in effect from March 16 through May 14, 2022. There is to be no open burning of brush or anything. For a full list of rules, please visit the DEC's website.

Next, is a letter from the County on their Hazardous mitigation plan. We adopted in 2021 and we have to adopt it again if we wish to try to get money from FEMA. Supervisor Hogue has requested a hard copy from the County before we adopt anything, and he is waiting for the hard copy. Matter tabled.

Next, is a letter from Al Hilber who lives on Plank Road, this letter has already been forward to he highway department for action with regard to the condition of the road in front of his home and the condition thereof.

We also received an email from Sandra Weiss who is a property owner in Lost Lake and who also owns property directly opposite the entrance to Lost Lake. She has observed the following: underground electric has been installed, underground cable has also been installed, constant work on the site itself and this past summer they ran hoses of water all over which directly effected the water availability to my farm. We are now wondering if there are others who still own lots within Lost Lake and how can we get in touch with them. They have also heard about a lawsuit and would like some further information on this matter. Lost Lake has now denied we owners access to our property, even though we pay the taxes, and we are unable to use the land or know what is going on. We, like others ask questions and receive no answers. They have now installed an electric gate and will not provide us with the access code to get to our property. I am available to meet in person or by Zoom but I would appreciate some answers and access to my property.

Next, is a packet that was received from Laura Smiros who lives in Lake Joseph. She has serious questions on the assessment of her home and met with Assessor Dennis Ketcham who attempted to bully and intimidate her when she inquired why her home was the highest assessed in Lake Joseph. She is attempting to alleviate a problem as professional and is happy to pay her fair share of taxes. She is confident that the board will act to correct this problem.

Lastly, is a letter of interest in the open seat vacancy on the Planning Board from Arthur Leaney-Levenson who is a resident on Rod & Gun Club Road. He thanks the board for their time.

Before we go any further, we have two speakers this evening, first is Heather Jacksy with the County Planning Department to discuss the expansion of the Sullivan County Rails to Trails program and their future expansion into the Forestburgh Rail Trail. Secondly, is Heather Guinin who is speaking to us about a new program called Bridge Back to Life Center which is a mobile treatment unit for mental health and psychiatric assessments and substance abuse treatments.

Heather Jacksey took the floor first, along with Freda Eisenberg the Director of the County Planning Department. They explained in detail the rails to trails program and how they are anxious to begin working on the Forestburgh Rail Trail along with further expansion of the trails through the county. Jack Gold of Lost Lake introduced himself and stated that Lost Lake is anxious to help and get started o the rail trail.

Heather Guinan requested use of the town hall parking lot for use for their program and their mental health treatment unit which is a large fully equipped large trailer.

UNFINISHED BUSINESS

PLANNING BOARD VACNACY – Now that there is a letter of interest, and Mr. Levenson is here, Supervisor Hogue recommended holding this over for executive session. All were in favor.

NY GRANT FUNDING – Councilwoman Ellsweig announced we made it through the first level of the grant application for a new roof, generator and generator for the highway department. We are moving on to the next round.

NEW BUSINESS -

SPECTRUM FRANCHISE AGREEMENT – Tonight we held our public hearing this agreement and are ready to move forward. MOTION by Councilwoman Ellsweig, seconded by Councilman Budofsky to enter into the franchise agreement with Charter/Spectrum communication with the agreement having a lifespan

of ten (10) years and rate remain at 3%. Vote: 5 ayes – 0 nays. Motion carried. The formal resolution will be enacted in April.

ADOPTING LOCAL LAW 2 OF 2022 REGARDING

Amendments to Escrow Deposits Code of the Town of Forestburgh

Dated: March 3, 2022

At a meeting of the Town Board of the Town of Forestburgh, Sullivan County, New York, held at the Town Hall, 332 King Road, Forestburgh, N.Y., on the 3rd day of March, 2022, there were:

Councilperson Budofsky offered the following resolution and moved for its adoption:

WHEREAS, the Town Board of the Town of Forestburgh determined that the Town's local laws, code, rules and regulations related to professional fees incurred by the Town in connection with certain applications did not adequately provide for the proper administration and enforcement of the Town Code of the Town of Forestburgh and directed that a draft local law amending the Town Code be prepared for the Town Board's consideration;

WHEREAS, local law 1 of 2022 was adopted providing for a moratorium temporarily prohibiting the acceptance, review, and approving building and land use project applications requiring escrows within the Town of Forestburgh for a period of up to three months to provide the Town Board adequate time to review and, if necessary, amend applicable Town Code provisions;

WHEREAS, proposed local law ____ of 2022 was developed with the assistance of the Town's consultants and was distributed to and reviewed by the Town Board members;

WHEREAS, the local law was referred to the Sullivan County Planning Board, and, as necessary to the clerks of the abutting towns;

WHEREAS, the comments, if any, of the Sullivan County Planning Board were considered by the Town Board;

WHEREAS, a duly noticed public hearing was held on February 3, 2022 (attached is the newspaper notice of the public hearing) and any public comments were carefully considered by the Town Board members;

WHEREAS, the Town Board is the only involved agency for this Type II action under NYS Environmental Quality Review Act (SEQRA)—the adoption of a local law amending the Town Code;

NOW THEREFORE BE IT RESOLVED that the Town Board declares itself lead agency pursuant SEQRA for the required environmental review of this action.

BE IT RESOLVED that the Town Board has carefully considered the SEQRA Environmental Assessment Form (EAF) Part 1 and has determined that the adoption of proposed local law 2 of 2022 is a Type II action under 6 NYCRR 617.5 (c) (33) for which no further environmental review is required;

BE IT RESOLVED that the Town Board hereby adopts Local Law No. 2 of 2022, entitled "Amendments Escrow Deposits Code of the Town of Forestburgh." and directs that the Local Law be filed as required by NYS Municipal Home Rule Law.
