HAZARD MITIGATION PLAN -

COUNTY MITIGATION PLAN RESOLUTION

WHEREAS Town of Forestburgh, with the assistance from the University at Albany's Albany Visualization and Informatics Labs (AVAIL), has gathered information and reviewed the County Hazard mitigation Plan; and

WHEREAS, the Sullivan County Hazard Mitigation Plan has been prepared in accordance with the Disaster Mitigation Act of 2000; and

WHEREAS Town of Forestburgh is a local unit of government that has afforded the citizens an opportunity to comment and provide input in the Plan and the actions in the Plan; and

WHEREAS Town of Forestburgh has reviewed the Plan and affirms that the Plan will be updated no less than every five years.

NOW THEREFORE, BE IT RESOLVED by Town Council that Town of Forestburgh adopts the Sullivan County Hazard Mitigation Plan as this jurisdiction's Natural Hazard Mitigation Plan and resolves to execute the actions in the Plan.

MOTION by Councilperson Ellsweig, seconded by Councilperson Budofsky to adopt said resolution. Vote: 5 ayes – 0 nays. Motion carried.

RESOLVED, that the Town Board of Forestburgh hereby appoints Justice Leroy Gunther, to fill the vacancy of Town of Forestburgh Justice until December 31, 2025, and it is further

RESOLVED, that Justice Leroy Gunther will not receive a salary for this position but rather receive an annual stipend of \$5,000, and it is further

RESOLVED, that the Town Board of Forestburgh hereby resolved that the currently vacant Town of Forestburgh Justice seat and one position of Town Justice, shall and hereby is terminated effective December 31, 2025, and there shall be one (1) Town Justice position henceforth, and it is further

RESOLVED, that the foregoing resolution is made subject to a permissive referendum and shall become binding unless a petition is filed with the Town Clerk of the Town of Forestburgh within 30 days of the adoption of this resolution and in the form prescribed by law.
