Councilperson Karen Ellsweig offered the following resolution and moved for its adoption:

WHEREAS, the Town Board of the Town of Forestburgh determined that the Town's local laws, code, rules and regulations related to retention of dogs for redemption was no longer practical and did not adequately provide for the proper administration and enforcement of the Town Code of the Town of Forestburgh and directed that a draft local law amending the Town Code be prepared for the Town Board's consideration;

WHEREAS, proposed local law 3 of 2022 was developed with the assistance of the Town's consultants and was distributed to and reviewed by the Town Board members.

WHEREAS, the local law was referred to the Sullivan County Planning Board, and, as necessary to the clerks of the abutting towns;

WHEREAS, the comments, if any, of the Sullivan County Planning Board were considered by the Town Board.

WHEREAS, a duly noticed public hearing was held on November 3, 2022 (attached is the newspaper notice of the public hearing) and any public comments were carefully considered by the Town Board members;

WHEREAS, the Town Board is the only involved agency for this Type II action under NYS Environmental Quality Review Act (SEQRA)—the adoption of a local law amending the Town Code;

NOW THEREFORE BE IT RESOLVED that the Town Board declares itself lead agency pursuant SEQRA for the required environmental review of this action.

BE IT RESOLVED that the Town Board has carefully considered the Environmental Assessment Form (EAF), Parts 1 to evaluate the proposed local law and hereby adopts the Short EAF Part 1 attached hereto;

BE IT RESOLVED that the Town Board, based on the Part 1 EAF has determined that the hereby declares that the adoption of proposed local law 3 of 2022 is Type II action under 6 NYCRR 617.5 (c) (33) and that no further review is required;

BE IT RESOLVED that the Town Board hereby adopts Local Law No. 3 of 2022, entitled "Amendments to Chapter 56-12 of Animals (Elimination of Subsection E) of the Town of Forestburgh." and directs that the SEQRA documentation and the Local Law be filed as required by NYS Municipal Home Rule Law.

BOARD MEMBER COMMENTS

Councilperson Steve Budofsky, attended a NYS Association of Towns- Attorney Webinar for the First amendment audits – relatively new (2018/2019) more prevalent now since Covid concerns have eased.

- 1-Issue of concerns regarding activists or citizens who seek to exercise 1^{st} amendment rights by recording interactions and activities between government staff and the public. The issues are concern when situations become confrontation which can result in arrest or litigation.
- 2-Courts have decided that while public meeting can be recorded towns can adopt rules (such as Forestburgh already has) to prevent disruption of town meetings and the obstruction of any public in attendance or town officials in the performance of their duties.
- 3-Definition of public official includes those elected and those appointed.
- 4-Recording is permitted in public areas provided no laws are broken.
- 5-However, areas and offices such as bookkeeper, assessor, code enforcement and supervisor can be off limits to those seeking to enter or record as well as other areas of the building. This does not extend to a

town clerk's office, however transactions between the clerk and a citizen may be conducted in private. A waiting area can also be designated for those waiting to see the clerk or other official until it's their turn. 6-Areas designated as a polling site on election day are a non-public forum and therefore 1st amendment rights do not apply and recording of any kind is prohibited.

7-Loitering is not a right nor is harassment, stalking or obstructing an employee or town official. Recording of a specific vehicle or employee, recording them walking to their car or focusing specifically on their vehicle could be considered harassment or staking. Also, following a public employee or official onto private property is illegal.

8-Gathering information is not an absolute right and is subject to restrictions.
