Planning Board

The Planning Board met for its regular December meeting and scheduled a public hearing for an application for a two-lot subdivision by The Hartwood Club. It will take place at the meeting on January 24, at 7pm. Also on the agenda for that meeting is an application for a lot improvement in the Forestburgh Pond subdivision. The Board will also conduct the review of the proposed new Zoning Code, as such a review and report to the Town Board is required under our present Zoning Code.

The Town Board has reviewed the draft, updated it and will hold a public hearing before voting on the final Zoning Code.

Our Town (as submitted by Town Historian, Sabina Toomey)

Just added to the archives of your town's history: Forestburgh Cemetaries Route 42. Research was done by L. Hornbeck in 1976. Additional information reprted from Town Hall records in October 1986 by Mary Case. Information obtained from records at Sullivan County Museum in Hurleyville by current Town Historian, Sabina Toomey, to have at our town. It was noted that many graves are unmarked and have only native stone as markers. Many grave have sunken with no identification. The earliest marker that was visible is the grave of Zephamiah Drake, entombed in 1804. However, since some graves were just mounds or markers, we will not know their date. The Town Hall records will be researched and hopefully answers will be found! Some questions that arose are: When was the cemetary first established?, Who were the last to be burried? How many souls were put to rest there?
