Hi Glenn,

Confirming receipt of the paperwork dropped off 2/14 for the above-referenced project. I was out sick late last week so I am just now getting to your voicemail. (i)

I also saw you included a note in the 2/14 submittal that you had issues reaching me via email. We have had a few domain changes in recent years – please ensure your system is using my most-recent email address (noted below), as I will not receive any email sent to past domains.

Based on my cursory review of the submittal, it appears that the majority of SCDPW's GML-239 comments have been addressed in the revised site plan and/or your letter dated 2/13. I have also forwarded the documents to our Highway Engineering unit for their review/comment as they performed the initial review.

As noted in SCDPW's GML-239 comments, a road access permit was required for the change-in-use of the pre-existing road access(es). Attached for your use/reference is our application for a road access permit; an example of typical Special Conditions for access permits; general provisions for driveway and drainage pipe installations; and an example insurance certificate naming the County of Sullivan as additionally insured (required from entity working within the road bounds – along with proof of workers' compensation).

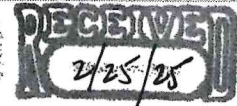
