#### **Town Board**

The Town of Forestburgh Town Board monthly meeting is usually held on the first Thursday of the month at 6:00pm located in the Forestburgh Town Hall unless otherwise stated. #### **Planning Board**

The Planning Board met for its August meeting with two matters on the agenda - a subdivision of a 138-acre parcel on both sides of Sackett Lake Road into three lots (5 acres, 63.4 acres; 70.2 acres) and an application for a special use permit, and site plan approval for the Grand Luxury Retreat, on Tannery Road. Both matters were tabled after presentation and questioning by the Board. With regard to the first matter, the applicant determined during the meeting that what it was seeking was a land division, dividing the 138-acre parcel into two parcels, and not a subdivision into three parcels. Their application has been revised and submitted and will be on the agenda for our regular September meeting on the twenty third of the month. The second matter - the Grand Luxury Retreat - was tabled following a detailed presentation after noting that the application was incomplete in a number of respects. No further submissions have been received from the applicant, and so remains tabled, as its time to submit for the September meeting has expired. No new matters have been presented to the Planning Board, so the only matter on the agenda will be the land division of the 138-acre parcel. # **Dog Control Officer**

Reminder to all dog owners: by law all dogs must have current RABIES vaccinations and be licensed. Rabies and license tags must be attached to the dog's collar or harness at all times. Sullivan County offers free rabies clinics throughout the year in various locations, or your veterinarian will administer the vaccine. There has been a significant increase in abandoned dogs, dogs roaming loose and bite incidents. Letting dogs run loose is not only illegal, it also creates a safety hazard for the public, the dog and other pets. Please be a responsible dog owner and a good neighbor.


Licenses are on sale now in the Town Clerk's office. Deer Management Permits will be available via instant lottery from August 1 through close of business day on October 1, 2025.


#### Forestburgh Day 2025

#### **Our Town** (as submitted by Town Historian: Sabina Toomey)

This past July was the bicentennial celebration of the D&H Canal. Although it is not located in our town, it has extreme importance to the property of it. The Town of Deerpark is so close it seems like a part or extension of Oakland Valley. In the late 1700's Philadelphia began buying coal in the Pennsylvania hills. It was not used as fuel until 1808. Bituminous coal was shipped from England. However, the War of 1812 shut off this supply which started the first energy crisis. William and Maurice Wurts believed their harder anthracite coal offered a new cheaper fuel. In 1823 the Wurts brothers hired Benjamin Wright and John Jervis to design a canal from the coal fields near Honesdale, PA to Eddyville, NY on the Rondout Creek near Kingston. From that point the coal could be shipped via the mighty Hudson River. This plan needed funding. Some came from the state, but much more was needed. The Wurts brothers devised a plan to invite investors to the Tontine Coffee House on Wall Street in New York City. There they demonstrated how anthracite coal would work. It was the country's first corporation capitalized at one million dollars. Wright and Jervis designed a canal four feet deep and 32 feet wide with 108 locks, 137 bridges and 26 basins 108 miles long. Ground broke on July 13, 1825 at Mamakating (Wurtsboro) by investor and President Philip Hone (Honesdale was named in his honor). The rest became part of "Our Town" industry and growth. So many places in our county and near by area's got their names.
