Town Board

The monthly Forestburgh Town Board meetings are usually held the 1st Thursday of every month at 7pm in the Town Hall, located at 332 King Rd., Forestburgh. The regular monthly Town Board meeting is scheduled for **Thursday**, **August 1**, **2019 at 7:00pm** in the Town Hall. Planning Board

The Planning Board met for its regular June meeting. Two matters were addressed. The first was an application by the Hartwood Club seeking approval of a small subdivision of a large lot to accommodate an existing residence. A public hearing was held, and the matter was advanced for consideration, and the application was unanimously approved. The second matter was an application by Mr. Ching Lam a prospective buyer of the Lost Lake Resort. The application was found to be incomplete, and there was a discussion of the procedures that would have to be followed should he choose to pursue the kinds of changes to the approved Master Plan, Final Environmental Impact Statement and Phase 1 site Plan approvals that are in place. None of the additional materials which Mr. Lam was advised are required have been received to date, so this application will not be on the Planning Board's July agenda. The sole item on the Agenda for the July 23, 7pm regular Planning Board Meeting at 7:00pm will be a review of the proposed local law imposing a moratorium on the receipt and processing of applications for new Planned Development Districts. (PDDs)

The next scheduled meeting of the Zoning Re-Write committee will be held on **August 20, 2019 from 7pm – 9pm** at the Town Hall, located at 332 King Road, Forestburgh. Announcements:

Our Town(As submitted by Town Historian, Sabina Toomey)

On July 20, 1779 our town and the settlements of Peenpack and Mahackamack(Port Jervis) were pillaged during the Revolutionary War. What is now called Hartwood Road (Rt 48) down to Peenpack Trail and what is now called Fort Decker in Port Jervis are marked with historical markers depicting the bloody path taken by Joseph Brant (Thayendanegea) along with his Torries and Mohawk Indians that led to the Battle at Minisink Ford. They camped at the four corners with their plunder and captives. Down Rt. 97, just at the point where the Roebling Bridge stands, they were crossing the river unaware that the militia was hiding in ambush to recover what Brant and his crew had taken. Accidentally, or purposely, one of

the militia scouts fired his gun alerting Brant to the ambush and soon the patriots were outmaneuvered on the hillside above the river. This led to a rushed retreat from the patriots as to regain a strategic advantage. They battled most of the afternoon and until late in the day. Brant and his forces killed about 45-50 men on the American side. Today the Minisink Battleground Park is a reminder of the patriotic lives that were lost as a sacrifice for Independence. Take some time this summer to visit the Minisink Battleground Park located off Route 97, 58 County Rd 168, in Barryville, NY 12719. There is no admission fee and the park is open daily May-October; 8am-dusk. For more information call (845)807-0287.


Public Health Offers MMR Vaccine Clinics

Starting July 3rd; Sullivan County Public Health Services is offering free weekly vaccination clinics for MMR- the vaccine that provides protection for measles, mumps and rubella- throughout the summer to the public, both for children and adults who are unsure of their immunity status or have had only one MMR. **Pre-registration is required to attend an upcoming clinic at**

www.health.ny.gov/gotoclinic/53. Please register ONLY for a clinic marked as "SCPHS MMR Clinic". The clinics run every Wednesday, starting on July 3rd, from 2-5pm at Public Health's Gladys Olmsted Building, 50 Community Lane, Liberty. These clinics are separate from regular monthly immunization clinics for other childhood vaccines, which are held the 2nd Wednesday of each month from 5-7pm. Routine childhood vaccines will not be offered at the weekly MMR clinics. Please talk to your healthcare provider before registering for a clinic if you have personal health concerns that might preclude you from receiving the MMR vaccine. Usage of the Town Pool For Private Events Requirements

- User MUST be a resident of the Town of Forestburgh.
- A refundable deposit of \$100 paid to the Town Clerk. Refunded when no damage has occurred and facilities are cleaned after event.
- User MUST have 2(two) Town of Forestburgh certified lifeguards on duty for the entirety of the event and pay them at their going rate each.
- User MUST submit, to the Town Clerk, a Certificate of Insurance from the user's insurance company naming the Town of Forestburgh as additionally insured for the date of the event. This must be provided before the date of the event.
- No alcoholic beverages are allowed on Town property.
- The facilities MUST be cleaned up after the event and it is the user's responsibility to do so.
