### **Town Board**

The monthly Forestburgh Town Board meetings are usually held the 1<sup>st</sup> Thursday of every month at 7pm in the Town Hall, located at 332 King Rd., Forestburgh. The regular monthly Town Board meeting is scheduled for **Thursday, September 5, 2019 at 7:00pm** in the Town Hall. ### **Planning Board**

The Planning Board met for its regular July meeting at which time two matters were addressed. The first was a review of the proposed local law establishing a moratorium on new or amended Planned Development Districts (PDDs) in Forestburgh. After identifying and suggesting a technical correction in the language of the proposed law, adoption was found to be consistent with Forestburgh's current zoning code, and it was unanimously recommended for adoption. The second matter addressed at the meeting was the adoption of a new Planning Board Application form. In connection with that, new escrow amounts were recommended to the Town Board for adoption. Lost Lake / Love Lake was not on the agenda as the proxy from Double Diamond to Mr. Lam to make application to the Planning Board to amend the PDD approvals previously given to Lost Lake was withdrawn, terminating the previously made application. The agenda for the August Planning Board meeting, to be held on **Tuesday August 27 at 7pm**, will include a sketch plan review of a proposal to be made by New York Land and Lakes, Inc. to develop the 548 acre Cavallacci parcel on Hartwood Road into a major subdivision comprising of 54 parcels.

### **Zoning Re-Write Committee**

The next scheduled meeting of the Zoning Re-Write committee will be held on **August 20, 2019 from 7pm – 9pm** at the Town Hall, located at 332 King Road, Forestburgh. Please note that due to a scheduling conflict, the meeting was moved from the 2<sup>nd</sup> Tuesday to the 3<sup>rd</sup> Tuesday for the August meeting.. The agenda will focus on reviewing the PDD and making recommendations to the Town Board.

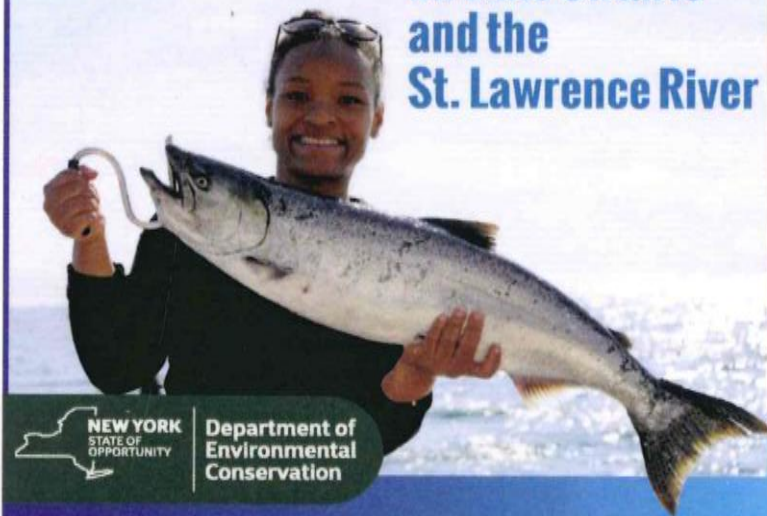
