#### Town Historian (as submitted by Town Historian, Sabina Toomey)

In the past we talked about Dr. Takamine who resided in Merriwold Park. Agnes de Mille who had a long time summer home there, and is famous in the arts. She was the niece of Cecil B. de Mille, a famous filmmaker responsible for countless motion pictures both silent and 'talkies' (as they were called). Agnes was a dancer, but she is famous for her choreography which spans more than a decade. She choreographed the 1936 version of Romeo and Juliet with Norma Shearer and Leslie Howard. She created her first ballet was *Black Ritual* in 1940. This ballet was the first to use black dancers. Her well known work is *Rodeo*. It was when she joined Rodgers and Hammerstein in 1943 to create *Oklahoma!*. She went on to choreograph some of the biggest musical hits, including, *Carousel, Brigadoon, Gentlemen Prefer Blondes* and *Paint Your Wagon*. She created the Agnes de Mille Heritage Dance Theater and toured the country from 1973-1974. She remained active in the arts until her death in 1993. I am so proud and thankful for all the pleasures she has given millons of people around the world. Our Town has place a Historical Marker in her honor at our theatrical golden spot- The Forestburgh Summer Theater. - If you do not have proof of prior rabies vaccination, your pet will receive a 1-year vaccination.
- Social distancing guidelines must be followed. Please remain at least 6 feet apart.
