INTRODUCING A LOCAL LAW REGARDING Solar Energy Systems

At a meeting of the Town Board of the Town of Forestburgh, Sullivan County, New York, held at the Town Hall, 332 King Road, Forestburgh, N.Y., on the 7th day of September 2023, there were:

Councilperson Ellsweig offered the following resolution and moved for its adoption:

WHEREAS the Town Board is undertaking a review of proposed local law 3 of 2023 regarding amendments to the Town Zoning Code, which includes proposed § 180-29 entitled "Solar Energy Systems" setting forth regulations related to solar energy development;

WHEREAS the Sullivan County Division of Planning reviewed proposed local law 3 of 2023 regarding amendments to the Town Zoning Code under General Municipal Law § 239-m and provided comments on various topics including provisions related to solar energy systems;

WHEREAS for administration purposes, the Town Board desires to adopt the solar energy regulations in § 180-29 of proposed Local Law 3 of 2023 as a separate chapter of the Town Code rather than as part of the Zoning Code.

BE IT RESOLVED that an introductory Local Law entitled "Solar energy Systems" appended hereto is hereby introduced before the Town Board of the Town of Forestburgh, Sullivan County, New York pursuant to authority under the New York State Constitution, the provisions of § 10 and § 22 of the New York State Municipal Home Rule Law, § 10 of the New York State Statute of Local Governments, and the New York State Town Law;

BE IT FURTHER RESOLVED that copies of the aforesaid proposed local law be laid upon the desk of each member of the Board;

BE IT FURTHER RESOLVED that the Board hold a public hearing on said proposed local law at the Town Hall, 332 King Road, Forestburgh, New York at 6 pm on September 27, 2023;

BE IT FURTHER RESOLVED that the Town Clerk publish or cause to be published a public notice in the official newspaper of the Town of Forestburgh of said public hearing at least five (5) days prior thereto;

BE IT FURTHER RESOLVED that the Town Supervisor or his designee is authorized to prepare the Environmental Assessment Form under the State Environmental Quality Review Act, and its implementing regulations;

BE IT FURTHER RESOLVED that the Town Supervisor or his designee is to provide notice, if required, under GML § 239-m to Sullivan County Planning Board and abutting municipalities under Town Law § 264; and

BE IT FURTHER RESOLVED that the Town Supervisor or his designee is authorized to take any other action required under law in furtherance of this resolution and passage of the proposed local law
