WHEREAS, Daniel S. Hogue, Jr., of the town of Forestburgh, County of Sullivan, New York, has been elected to the office of Supervisor of the Town of Forestburgh; and

Whereas, Teresa Collins, of the town of Forestburgh, County of Sullivan, New York has been elected to the office of town Clerk/Tax Collector of the Town of Forestburgh; and

WHEREAS, Steven Budofsky of the Town of Forestburgh, County of Sullivan, New York has been appointed to the office of Deputy Supervisor of the Town of Forestburgh; and

WHEREAS, LeRoy C. Gunther of the Town of Forestburgh, County of Sullivan, New York has been elected to the office of Town Justice of the Town of Forestburgh; and

WHEREAS, Glenn Gabbard, of the Town of Rockland, County of Sullivan, New York has been appointed to the office of Building Inspector/Code Enforcement of the Town of Forestburgh; and

WHEREAS, Joseph Ruggeri, of the Town of Forestburgh, County of Sullivan, New York has been elected to the office of Superintendent of Highways of the town of Forestburgh; and

NOW, THEREFORE, we as respective officers above, do hereby undertake with the Town of Forestburgh that we will faithfully perform and discharge the duties of our office, and will promptly account for and pay over all moneys or property received as a Town Officer, in accordance with the law; and

This undertaking of the Town Supervisor is further conditioned upon that he will well and truly keep, pay over, and account for all moneys and property, including special district funds, belonging to the the Town and coming into his hands as such Supervisor; and

This undertaking of the Town Tax Collector is further conditioned that she will well and truly keep, pay over and account for all moneys coming into her hands as such Collector of Taxes and Assessments; and The Town does and shall maintain insurance coverage, presently with NYMIR (Insurance Company), a blanket bond in the sum of \$15,000 plus an additional \$600,000 for the collector of taxes, an additional \$100,000 for the Town Supervisor to indemnify against losses through the failure of the officers, clerks and employees covered thereunder faithfully perform their duties or account properly for all monies or property received by virtue of their positions or employment, and through fraudulent or dishonest acts committed by the officers, clerks and employees covered thereunder.
